THE TED SEEBERG AWARD

For outstanding Contribution To The Canadian Parking Industry

Examples:

- Service to the Canadian Parking Association or other aspects of the industry
- An innovation (could be an invention or a program)
- An outstanding contribution in design, maintenance or technology
- A lifetime achievement or a single achievement

THE ED KEATE AWARD

For Outstanding Contribution To Advancement Of Knowledge In The Parking Industry

Examples:

- Publishing an article in The Parker
- Training
- Research
- Symposium or Seminar
- Education
- Parking as an Academic Pursuit, e.g. lifetime

Contributions to the success of the industry range from the tireless dedication of volunteers to the creation of innovative systems and technology development. Many members of the parking industry have been acknowledged by Principals of Read Jones Christoffersen through two awards: The Ted Seeberg Memorial Award for Outstanding Contribution to the Canadian Parking Industry and the Ed Keate Award for Outstanding Contribution to Advancement of Knowledge in the Parking Industry.

Nominations to be submitted in writing, up to one page in length, stating the following:

- Demonstrate how the nominee has had an impact on the industry.
- Describe why you think the nominee's achievement is outstanding.
